



FIT TO FLY PROMOTIONS – TERMS & CONDITIONS

GENERAL

Promotions and the Promoter

- 1. These terms and conditions apply to the following promotions being run during the Fit to Fly Challenge 2025 (**Event**):

Privacy and personal information

- 7. The Promoter collects personal information about Eligible Entrants, including the information they provide through their completed registration.
- 8. The Promoter collects this personal information for the purpose of conducting the Promotions, awarding prizes and rewards to Eligible Entrants (where applicable), facilitating the Promoter's internal business operations, including the fulfilment of any legal requirements, as well as providing Eligible Entrants with information about how they can support the Promoter to help make a difference to rural and remote Australian communities.

By entering any of the Promotions, the Eligible Entrant consents to the Promoter using and disclosing their personal information to the Promoter's agencies, affiliated organisations and other third parties engaged to provide services in connection with the Challenge and the Promotions, including to contact the Participant in relation to the Challenge and the Promotions.

of opportunity or loss of profits) whether direct, indirect, special or consequential, arising in any way out of the Promotions, including, without limitation:
